**The AIFC Academy of Law is an educational** platform, established to provide educational legal programs on the AIFC Law.



The mission of the AIFC Academy of Law is the development of the AIFC legal system through teaching students with the principles of the AIFC law, as well as providing legal education of an international value. At the early stage of AIFC development, it is crucial for the AIFC to actively increase an awareness of its legal system for the benefit of both AIFC and non-AIFC lawyers from diverse backgrounds and jurisdictions.



**Objective:** The main objective of the AIFC Academy of Law is to provide learning and development services. This institution will function as the education, information and promotional institution for familiarising the legal community with the AIFC legal system, principles of AIFC laws, and dispute resolution options – which constitute a core component of the

AIFC value proposition. The strategic purpose of the AIFC Academy of Law is driving the development of the intellectual capital of the legal profession and promoting legal knowledge, which is necessary for working in the AIFC jurisdiction.



**Strategy:** prepare professionals for international commercial law practice; cooperation with international education institutions; provision of other educational services.

**Activities:** the AIFC Academy of Law main activities are as follows:

1) training specialists for work in the AIFC jurisdiction;

2) legal publications in order to raise awareness of the AIFC and its jurisdiction;

3) organization of educational and informational events for the legal community;

4) provision of platform for providing free legal consultations by law firms to interested parties at no cost.

# **AIFC Foundations Program for Future Lawyers 2019**

As part of its activities, the AIFC Academy of Law in September 2019 launched education program "the AIFC Foundations Program for Future Lawyers", designed specifically for students currently enrolled in their third or fourth year of undergraduate legal studies, or in a postgraduate law program, or in other related.

The program consists of five (5) modules covering the key "foundational" subjects required for students to gain a comprehensive understanding of the AIFC legal system. The program includes the following modules: Foundations in AIFC Legal Framework; Foundations in AIFC Dispute Resolution; Foundations in AIFC Financial Services Regulation; Foundations in the Astana International Exchange (AIX); and Foundations in Islamic Finance.

Each module provides a total of five hours of classroom time, delivered as live lectures by AIFC executives, employees, and experts who are subject matter specialists. Mandatory pre-work reading assignments must be completed prior to each lecture. Students should expect to spend approximately three hours of preparation work for each one hour of live lectures (thus, approximately 15 hours of preparation time for each five-hour lecture module). In total, the Program will consist of 100 hours, 25 hours for live lectures and 75 hours for pre-work reading/preparation. Some lecturers also may assign additional post-lecture work to reinforce the learning process. The lectures will take place in the evening at the AIFC to accommodate student schedules. Lectures are held every Tuesday from 17-00 to 19-00 in the AIFC premises in accordance with the schedule. The final session for each module consists of a workshop whereby students will be given the opportunity to give oral presentations on specified topics based on their learnings. These presentations will be evaluated by the instructor. Since each Foundations module covers an independent topic, students may take one or more modules. However, Certificates will be granted only to students who have (i) successfully completed all five Foundations modules (including the pre-work and attendance at all lectures), (ii) passed the oral presentation assessment, and (iii) received approval for certification by the Academic Council of the AIFC Academy of Law.

To participate in the AIFC Foundations Program for Future Lawyers, students had to meet the following criteria:

(i) be currently enrolled in their third or fourth year of undergraduate legal studies, or in a postgraduate law program, or in other related disciplines (i.e. business and management; interdisciplinary programs related to business, management and law, public administration, etc.);

(ii) have proficient English language speaking and writing skills; and

(iii) pass an interview before the commission, which included Program lecturers and representatives of the AIFC Academy of Law.

To date, 54 students from 4 universities of Kazakhstan (Nazarbayev University, KazGUU, ENU, KIMEP) and 2 foreign universities (BPP, University of Edinburgh) are studying at the first AIFC Foundations Program for Future Lawyers.





# AIFC Foundations Program for Business Professionals and Students 2020

**OVERVIEW**: The 1st and 2nd steps of the AIFC Foundations Program for Business Professionals and Students 2020 consist of five (5) modules:

Foundations in AIFC Legal Framework; Foundations in AIFC Dispute Resolution; Foundations in AIFC Financial Services Regulation; Foundations in the Astana International Exchange (AIX); and, Foundations in Islamic Finance.

ASSESMENT SYSTEM: Final presentations for the assessment. Certificates to be granted for the successful completion of the Foundations Program.

Next 3rd and 4th steps consist of Practical work (Internship Program for students and Think Tank Program for Professionals) based on delivery of final Findings for development of the AIFC brand.

**FORMAT:** The Foundations Program to be delivered as the live lectures with pre-work reading and final presentation workshop.



**SPEAKERS and TUTORS:** AIFC executives, employees, and experts who are subject matter specialists

**TARGET AUDIENCE:** Students and professionals, including local and foreign students/professionals.



**TIMING:** Two Program runs (February 2020 – April 2020 & September 2020 – November 2020)

Five modules, each consisting of five 1-hour lectures; 75 hours home study;

In total, the Program will consist of 100 hours, 25 hours for live lectures and 75 hours for home study.

#### **ELIGIBILITY CRITERIA:**

(i) students of the 3rd or 4th year of undergraduate or postgraduate studies and/or specialists with a diploma of higher education;

- (ii) proficient English language speaking and writing skills; and
- (iii) pass an interview before the commission.




